Food Vendor Application

Strut Food Vendors will be located at strategic locations through out the festival foot print. The goal of having food at the Strut is to showcase local restaurants and vendors in a festival like atmosphere. Mobile and stationary food vending are acceptable. Food must be served from an enclosed tent (not provided) or other structure during the event and must fit with in the 10'x10' foot print we assign, unless accommodations for a larger space have been approved by the Food Committee. Expect to set up between 6-9 AM and ready for County Food Inspector by 9 am. Tear down between 8-9 PM on the day of the Strut.

Fees:

- Local restaurants (EAV) and East Atlanta neighborhood residents: \$150.00
- Vendors and restaurants outside the East Atlanta neighborhood: \$300.00
- Dekalb County Permit Fee for non licensed vendors: \$75
- Over sized site needs will need to pay for extra space
- Fees and permit applications need to be received by food committee of the Strut before August 12th 2009 and are non-refundable for accepted food vendors
- The East Atlanta Strut is a rain or shine event
- Food vendors must adhere to DeKalb county board of health standards: Please see Food code 290-5-14.09 Special Food Service Operations for specifics
